MEMORANDUM OF AGREEMENT. COMPARED

THIS CONTRACT AND AGREEMENT, made and entered into on this the 16th day of January. 1924, between B-Jack Oil Company, a corporation of Sapulpa, Oklahoma, first party, and J.E. Fitzpatrick of Tulsa Oklahoma, second party,

WITNESSETH: That, WHEREAS, first party is the owner of an oil and gas lease executed on the 6th day of March, 1919, by Ellen Colbert as lessor to R. E. Lynch, covering the following described lands situate in Tulsa County, Oklahoma, as follows, to-wit:

The West Half of the Southwest quarter of Section Sixteen (16), Township Nineteen (19) north, Range Twelve (12) East; and,

WHEREAS, first party is now the owner of said lease by assignment; and,

WHEREAS, first party is also the owner of oil and gas leases by assignment covering the following described lands situate in Tulsa County, Oklahoma, to-wit:

The South Half of the Northeast Quarter of Section Twenty-one (21), Township Nineteen (19) North, Range Twelve (12) East,

and is therefore the owner of the oil and gas rights, thereunder as expressed in said oil and gas leases; and,

WHEREAS, both parties hereto are mutually desirous of testing said above described lands for oil and gas below the 1200 feet horizon,

NOW, THEREFORE, it is agreed between the parties hereto, that second party will within thirty days from date hereof commence the drilling of a well, at his option, on either of said above described tracts of land and prosecute the drilling thereof with due diligence to what is known as the "Turkey Mountain" Sand, found at approximately 2,350 feet, unless oil or gas is found in paying quantities at a lessor depth.
