DEED OF TRUST. COMPARED THIS DEED, Made and entered into this 18th day of February, 1924, by and between L. N. Van Antwerp and Louise E. Van Antwerp, his wife, of Julsa, Okla, parties of the first part, and M. Hughes, Trustee, party of the second part, and the CENTRAL SAVINGS AND LOAN ASSO-CIATION, of Marshall, Missouri, party of the third part.

WITNESSETH, That the said parties of the first part, in consideration of the debt

and trust hereinafter mentioned and created and the sum of One Dollar to them paid by the party of the second part, the receipts of which is hereby acknowledged, do by their presents, Grant, Bargain, Sell, Convey and Confirm unto the said party of the second part, the following described Real Estate, situated in the County of Tulsa, and State of Oklahoma, to-wit: Lot One (1), Block Thirteen (13), in East Lawn Addition to the City of

Tulsa, Oklahoma,
