P. Oak, of the City of Tulsa, Oklahoma, party of the second part, subject, however, to the exceptions and reservations hereinafter contained and stated, the following described real property and premises situated in Tulsa County, tate of Oklahoma to-wit:

The Southeast Quarter (SE1) of the Southwest Quarter (SW1) of the Northeast Quarter (NE1) of Section Five (5), Township Nineteen (19) North, Range Twelve (12) East, containing ten (10) acres, more or less, according to the United States Government survey, excepting however from this grant; and reserving unto the grantor herein William J.
