mises and that by reason of the acts of the defendant and the faults of the defendant, plaintiff is entitled to a decree of divorce as prayed for.

The court further finds that plaintiff is the owner of the following real estate, subject to a mortgage of \$900.00, to-wit:

> Lot Ten (10), in Block Two (2) in East Lynn Addition to the City of Tulsa , Tulsa County, Oklahoma.

which plaintiff earned prior to his marriage with said defendant, and that said defendant did not in any way contribute any sum toward the payment of said property, That the same never was homestead of said plaintiff and defendant and that plaintiff should have such property free of any claim, right, title or interest of said defendant therein by reason of having been the wife of said plaintiff.

IT IS THEREFORE, ordered, adjudged and decreed by the Court, that the marriage relations heretofore existing between George M. Webster, and Ruth Webster, be and the same is hereby dissolved and both parties are released from the same.

It is further ordered, adjudged and decreed that said plaintiff shall have the following described premises, to-wit:

> Lot Ten (10) in Block Wo (2) East Lynn Addition to the City of Tulsa Tulsa County, Oklahoma,

as his own, free from any right, title or interest that defendant may have had therein by reason of having been the wife of said plaintiff and that he shall have said property and the appurtenances thereunto appertaining and belonging to him and to his heirs and assigns forever, free from any right, of said defendant or any other person or persons claiming thru her, and that said defendant is forever barred from claiming any right, title or interest in end to said premises or any part thereof.

It is further ordered that the plaintiff pay the costs of this action.

It is further ordered by the Court that this decree do not become absolute and take effect until six months from the date hereof.
