ASSIGNMENT OF OIL RUNS.

COMPARED

THIS AGREEMENT, Made and entered into on this 23rd day of February, 1924, by and between W. C. GATES and W. C. Cates, Attorney for Roy Barnes, et al, as first parties, and TULSA INDUSTRIAL LOAN & INVESTMENT COMPANY, second party, WITNESSETH:

THAT, WHEREAS, first party, W. C. Cates, has applied to second party for a loan in the sum of Thirteen Hundred Fifty-five Dollars Twenty cents (\$1355.20), and said loan to be repaid at the rate of Sixty Seven Dollars Twenty-six Cents (\$67.26), semi-monthly over a period of ten (10) months; and,

WHEREAS, first parties desire to secure the payment of said loan by assigning to second party certain oil runs as hereinafter specified, said assignment being intended merely
