KNOW ALL MEN BY THESE PRESENTS: Dated February 25, 1924.

That whereas V. G. Smith and wife, Floy Smith did on the 16th day of January, 1924 make, execute and deliver to G. Z. Jenkins a certain promissory note of that date for the principal sum of \$2,000 payable in monthly installments of \$34.00 including interest until fully paid and on said date for the purpose of securing said note said V. G. Smith and wife, Floy Smith made, executed and delivered to said G. Z. Jenkins a certain mortgage in writing of that date covering all of the East Forty Six and Two Thirds Feet (46 2/3) of the West Ninety Three and One Third Feet (93 1/3) of Lots One (1) and Two (2) Block Twenty-two (22) in Irving Place Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof,

And, whereas said G. Z. Jenkins for and in consideration of the sum of One and No/100 Dollars and other valuable consideration has this date sold to Robt. E. Adams thirty-six of said payments mentioned in said note and secured by said mortgage as follows, to-wit:

First payment maturing March 16, 1924 and continuing consecutively on the 16th day of each and every month thereafter until thirty-six of such payments shall have been made.
