ORDER APPROVING FINAL REPORT
 DECREE OF DISTRIBUTION AND
 HEIRSHIP.

Now, on this 3 day of March 1924, same being one of the regular judicial days of the January term of said Court, the above entitled matter coming on for hearing on the final report of administratrix and petition for final distribution and for determination of heirship, and the petitioner, Lillie M. Moore, appearing in person, and by her attorneys, Bell & Fellows, and it appearing to the Court that all the next of kin, heirs and persons interested have filed written waiver of notice of time and place of this hearing, and it further appearing that notice has been given according to law and pursuant to the order of this Court, and from the proofs, evidence and argument of counsel and upon due consideration thereof the Court finds that Lillie M. Moore, Lewis Moore, Frankie M. Benedict and Etta Z. Moore are the sole and only heirs at law of the said Benjamin F. Moore, also known as B. F. Moore, deceased, the said Lillie M. Moore being the widow of the deceased, and the three persons last above named being children of the said Benjamin F. Moore or B. F. Moore, deceased; and that each were entitled to share in the distribution of said estate, as follows:

One-third interest to Lillie M. Moore,
 Two-Ninths interest to Lewis Moore,
 Two-ninths interest to Frankie M. Benedict,
 Two-Ninths interest to Etta Z. Moore,

it further appearing to the Court that the said Lewis M. Moore, Frankie M. Benedict and Etta Z. Moore have conveyed all of their right, title and interest in and to the lands hereinafter described to the said Lillie M. Moore, the decree of distribution to said estate should be made to her,

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that the lands hereinafter described be, and the same are hereby set over and distributed to the said Lillie M. Moore, said lands being located in Tulsa County, State of Oklahoma, and described as follows, to-wit:

Lot 4 in Block 445 in the original town, now City of Tulsa, Tulsa County, Oklahoma, and Lot 11 in Block 206 in Woodlawn Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof,

and it appearing that no other property was owned by the deceased at the time of his death, no further distribution is made.

IT IS FURTHER BY THE COURT ORDERED, ADJUDGED AND DECREED that the final report be, and the same is hereby approved, the bond of the said administratrix, Lillie M. Moore
