EXECUTOR'S DEED COMPARED

THIS INDENTURE, Made the 12th day of November 1923, by and between EXCHANGE TRUST COMPANY, a Corporation, of Tulsa, Oklahoma, the duly appointed, qualified, and acting executor of the last will and testament of Dora B. And, whereas, the said County Court, upon due and legal return of the proceedings under said order of sale, made by the said party of the first part on the 30th day of October, 1923, after making the said sale, did, on the 10th day of December, A.
