AFFIDAVIT.

Lizzie Abrams being duly sworn upon her oath deposes and says: thet she is about O years of age; that she resides about seven miles from Broken Arrow in Wagoner County and State of Oklahoma; that she is a member of the Creek Tribe of Indians known as a Freedman, and has resided in the Creek Nation for about 70 years last past; that she was well acquainted with one Ben Franklin a Creek Freedman, and had known him for about 30 years well and intimetely and was well acquainted with the members of his family; that said Ben Franklin died on or about the ----- day of February, 1905, about eight miles southeast of Julsa, Oklahoma, on his allotment of land which was situated in Julsa County, State of Oklahoma; that st the date of the death of seid Ben Franklin he was living with his wife, Jane Franklin, on his allotment as aforesaid; that said Ben Franklin married said Jane Franklin about 15 years ago and they lived together as husband and wife until the date of his death as aforesaid; that said Ben Franklin left no child surviving him or children, hor descendants of a deceased child or children, but he left as his sole and only heirs at law his two sisters, Lizzie Millet and Eliza Franklin Pettit; that no children were ever born unto said Ben Franklin and Jane Franklin; that said Jane Franklin since the death of her said husband, Ben Franklin, has married one H. C. Duncan with whom she is now living and residing upon the allotment of her deceased husband, Ben Franklin; that Willie Franklin was an illigitimate child of the said Ben Franklin by Maggie Davis; that Lucy Morgan was a daughter by a former marriage of Jane Franklin and was not the child of Ben Franklin.
