SEWER CONTRACT

COMPARED

THIS AGREEMENT, made and entered into this 19 day of Feb, 1924, by and between the CITY OF TULSA, OKLAHOMA, party of the first part, and GILES A. PENICK of Tulsa County, Okla., State, party of the second part; WITNESSETH;

For and in consideration of the use of and connection with the sewer system in SEWER DISTRICT NO Main of said City of Tulsa, and the covenants and agreements herein contained, the said part---- of the second part do---hereby covenant and agree with the said City of Tulsa, Oklahoma, as follows; to-wit:

That the said party of the second part----- is the fee owner of the following property covered by this contract, to-wit:

Lot 8 Blk 1 Brennen-Reed Add to the City of Tulsa, Okla.

That the said party of the second part is hereby authorized and permitted to construct, connect with and make use of the sewer in SEWER DISTRICT NO. MAIN of the City of Tulsa, upon the said party of the second part paying the entire cost of such sewer construction and use, and in addition paying to the said City of Tulsa, the sum of Five (5%) per centum of the cost of such construction, connections and use, as an engineering fee for the supervision of such construction, connection and use.

That said party of the second part further agrees that such sewer construction, connections and use shall be in accordance with plans and specifications required by the City Engineer of the City of Tulsa, and no such sewer shall be constructed, connected or used without said second party securing and paying for the permits required by the Charter and Ordinances of the City of Tulsa, and such sewer connection, construction and use being approved by the City Engineer.
