RELEASE OF MORTGAGE

COMPARED

WHEREAS, Henry O. Green and Nellie E. Green, his wife, of Tulsa County, State of Oklahoma, as Mortgagors, did on the 27th day of January, 1921, execute a certain mortgage recorded on the 28th day of January, 1921, in the office of the County Clerk, Ex-Officio Register of Deeds, of Tulsa County, State of Oklahoma, in Book 316, at page 314, to EXCHANGE TRUST COMPANY, a corporation, of Tulsa, Oklahoma, Mortgagee, upon the following described real estate situated in Tulsa County, State of Oklahoma, to-wit:

All that portion of Lot 6, Block 200, Woodlawn Addition to the City of Tulsa, Oklahoma, described as follows: Beginning at the Northwest corner of said Lot 6, running thence in a Southerly direction along the West line of said Lot a distance of 12.8 feet, thence in an easterly direction and parallel with the South line of said Lot 6, until it intersects the North line of said lot, thence due West along the North line of said Lot 6, to the place of beginning.

WHEREAS, all the indebtedness secured by said mortgage has been satisfied and discharged in full and all the obligations mentioned therein have been performed,

NOW, THEREFORE, the said EXCHANGE TRUST COMPANY, Mortgagee in the above mentioned mortgage, does hereby discharge and release said mortgage and does remise, release and forever quit claim all its right, title and interest in and to said real estate unto the said mortgagors, their heirs and assigns.
