Hodge, as father and Natural guardian of May Hodge a minor and incompetent because of tender years, of the Creek Nation, Indian Territory, party of the first part, for and in consideration of the sum of Two Hundred & Five (\$205.00) Dollars paid to me, the receipt whereof I do hereby acknowledge, do hereby give , grant, bargain, cell and convey unto the MISSOURI, KANSAS AND OKLAHOMA RAILROAD COMPANY, a corporation created and existing under and by virtue of the laws of the Territory of Oklahoma, party of the second part, its successors and assigns, the following tract or parcel of land, real property and premises, situated in the Creek Nation, Western Judicial District of the Indian Territory, that is to say:
