VACATION OF PORTION OF PLAT OF
HOMEBUILDERS ADDITION TO THE
CITY OF TULSA, OKLAHOMA.

KNOW ALL MEN BY THESE PRESENTS:

THAT, HI-LAND INVESTMENT COMPANY, a corporation of Tulsa, Oklahoma, being the owner and proprietor of all the lots and blocks, contained in and laid out on that certain plat, known as Homebuilders Addition to the City of Tulsa, Oklahoma, and being also the owner of all that part of the North sixty acres of the East one-half of the Northwest Quarter of Section Twenty-five (25), in Township Twenty (20) North, Range Twelve (12) East, in Tulsa County, Oklahoma, (not embraced in said Homebuilders Addition nor in Brookdale Addition to said City of Tulsa), which latter tract immediately adjoins said Homebuilders Addition aforesaid, does hereby vacate and set aside that portion of the plat of said Homebuilders Addition lying within the following bounds, to-wit:
