AGREEMENT AND DECLARATION OF TRUST
OF THE
BANKSTON'S NEW WAY CLEANING AND DYE WORKS.

THIS AGREEMENT MADE THIS 5th day of March, 1924, by J. H. Bankston, F. C. Hays, M.A. Bankston, ----- and ----- together with their assigns, herein designated "Subscribers" and J. H. Bankston, F. C. Hays, M. A. Bankston, and----- together with their successors, herein designated "Trustees", WITNESSETH:

THAT WHEREAS, the subscribers propose to transfer, assign and deliver to the Trustees, under designation of Bankston's Cleaning and Dye Works, certain property detailed and described as follows, to-wit:

A Lease on a store room, office fixtures and other equipment to be used in establishing a cleaning and dye works in the City of Tulsa, Oklahoma, and the expert knowledge and good will of the subscribers,

As more fully appears and is shown in a schedule identified by the signature of the parties hereto in papers properly executed and filed with the Trustees; and the Trustees for the purpose of defining the interests of the subscribers and their assigns in such property, have agreed to issue to the subscribers negotiable certificates for Nine thousand (9,000) shares of which all shares shall be common and no shares shall be preferred and each share to be of the par value of One (\$1.00) Dollar .

NOW, THEREFORE, The Trustees hereby declare that they will hold all money and property transferred to them or acquired by them as Trustees doing business as the BANKSTON'S NEW WAY CLEANING AND DYE WORKS together with the proceeds and profits to accrue therefrom in trust, to manage and dispose of the same for the benefit of the holders of "certificates" of said company aforesaid and according to the equitable value or priorities that may be lawfully expressed therein, and in the manner and subject to the terms, conditions and stipulations hereinafter contained to-wit;

It is the expressed intention and understanding herein signified that the Bankston's New Way Cleaning and Dye Works is a Trust Estate and not a partnership; that all property of
