without notice and shall be entitled to a foreclosure of this mor tgage for the satisfaction hereof.

FIFTH. In case of default in payment of any insurance premium, taxes or assessments, the holder of this mortgage may pay and discharge the same, and all such sums so paid shell be secured by the lien of this mortgage and draw, interest at the rate of ten per centiper amount provided that such payments by the mortgagee shall not operate as a waiver of the right to foreclose the mortgage under the provisions of the fourth special covenant hereinbefore set out.
