Now Therefore, in consideration of the premises and for the purposes herein set forth, it is hereby agreed by the parties hereto that all rentals and other payments to be made to, or for the benefit of the lessor, or her successors in interest, under the terms of said lease may be made to the Commercial National Bank of Muskogee, Oklahoma, or its successors, which said bank and its successors shall for such purposes be the agent of the said Ernest R. Anthis, 48 Archie K. Wright and Benjamin F. Wheeler, their heirs, administrators, executors and assigns, and shall continue to act as such agent and be and remain the depository for said rentals and other payments regardless of any change in the ownership of said land; and that, except as modified hereby, said lease shall be and remain in full force and effect.
