" Beginning at a point in the south line of Section 5, T. 19 N., R. 12 E., 184.0 feet east of the south west corner of said section, said point being in the present northwesterly right of way line of the Missouri, Kansas and Texas Railway and being 50 feet distance at right angles from center line of main track of said Missouri, Kansas and Texas Railway at chaining station 12171 plus 22.7; thence westerly, along said south line of Section 5, 33.0 feet; thence to the right, through an angle of 151 degrees, 13 minutes, in a northeasterly direction, a distance of 1348.2 feet to a point 230 feet northwesterly at right angles from the said center line of main track of the Missouri, Kansas and Texas Railway at chaining station 12184. plus 29.8; thence to the right, through an angle of 7 degrees, 9 minutes, in a northeasterly direction, parallel to said center line of main track of the Missouri, Kansas and Texas Railway, a distance of 1405.1 feet to a point in the north and south center line of said Section 5; thence to the right, through an angle of 110 degrees, 35 minutes, in a southerly direction, along said north and south center line of Section 5, a distance of 191.2 feet, more or less, to a point in the said northwesterly right of way line of the Missouri, Kansas and Texas Railway, said point being 50 feet distant at right angles from said center line of main track of the Missouri, Kansas and Texas railway; thence to the right, through an angle of 69 degrees, 25 minutes, in a southwesterly direction, along said northwesterly right of way line, a distance of 2647.8 feet to the point of beginning; containing 8.62 acres more or less.
