

of the South West quarter, less Three and 61/100 (3.61) Acres occupied as Right of Way by the St. Louis and San Francisco Rail Road, of Section Twenty-seven (27), and the North East quarter of the South East Quarter of the South west Quarter of Section Thirty-four (34), Township Twenty (20) North and Range Thirteen (13) East, and the North Half of the North West Quarter of the North West Quarter of Section Twenty-one (21), Township Twenty-two (22) North and Range Fourteen (14) East, and the North West Quarter of the South East Quarter of the North West Quarter of Section Three (3), and the North Seven and 45/100 (7.45) Acres and the South West Five and 90/100 (5.90) Acres of Lot One (1) and the North East Seven and 25/100 (7.25) Acres of Lot Eight (8) of Section Four (4), Township Twenty-three (23) North and Range Twenty-two (22) East, of the Indian Base and Meridian, in Oklahoma, containing 487 Seventy-six and 99/100 (76.99) acres, more or less, as the case may be according to the United States survey thereof, subject, however, to all the provisions of said Act of Congress.

THIS INDENTURE, Made the Thirty-first day of March in the year of our Lord nineteen hundred and Twenty-four (1924) between A. L. Bradford and Idell I. Bradford ( husband and wife) the parties of the first part, and Wm. S. Butts and Ruth E. Butts husband and wife as joint owner with right of survivorship, the parties of the second part,

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of One Dollar and other considerations gold coin of the United States of America, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT unto the said parties of the second part, and to their heirs and assigns forever, all the certain lot, piece or parcel of land, situate, lying and being in the City of Tulsa County of Tulsa and State of Oklahoma and bounded and particularly described as follows, to-wit:
