This agreement made and entered into this 21st day of February, 1923, between Campbell & Sanders, a co-partnership composed of H. Ross Campbell and W. W. Sanders, party of the first part, and Burgess Gasoline Company, composed of J. J. Riner, Matt McCormick, W. W. Sanders and H. Ross Campbell, parties of the second part, witnesseth;

That whereas, the first parties are the owners of a certain contract dated January 19, 1923 and entered into between W. E. Hancock, J. H. Middleton, Sanders Oil & Gas Corporation and J. W. R. Crawford & Sons, Inc., as first parties and Campbell & Sanders, a co-partnership composed of H. Ross Campbell and W. W. Sanders as second party, by the terms of which contract the first parties have covenanted and agreed to sell to second parties all casing head gas issuing from wells of first parties on certain leases for oil and gas described in "Schedule A" of said contract, which contract further provides for terms and method of payment for such casing head gas sold thereunder and for the construction and operation of a casing head gasoline plant for the manufacture of such casing-head gas into gasoline, and,

Whereas, the first parties hereto desire to sell and assign to second parties hereto said contract and all rights pertaining thereto and the second parties hereto desire to purchase from first parties said contract and rights;

Now therefore, the said first parties, for and in consideration of the sum of \$10.00 and other good and valuable considerations in hand paid by second parties hereto to the first parties hereto, receipt whereof is hereby acknowledged, have sold and assigned and do by these presents bargain, sell, assign, transfer and set over to and unto the second parties hereto all of the said certain contract hereinabove described, and all of the rights and privileges arising thereunder and pertaining thereto, which said contract is hereto attached and made a part of this agreement; it being the intent and purpose of this assignment to transfer fully to the second parties hereto said casing-head gas contract and all of the powers, rights and privileges therein granted to first parties hereto.

To have and to hold the said contract, rights and privileges hereby assigned, to the said parties of the second part, for and during the full term of said contract, subject to the terms and conditions in said contract contained, to be performed by the first parties hereto or their assigns.
