ASSIGNMENT OF OIL AND GAS LEASE

Whereas, the biberty Oil Company, Incorporated, desires to sell, transfer, set over and assign to Elo Oil Company the entire leasehold estate described in paragraphs one, two and four, and an undivided one-half interest in and to the lease hold estate described in paragraph three.

Bassett, Trustee in Bankruptcy, do hereby sell, assign, transfer and set over unto said Elo Oil Company its heirs, siccessors and assigns, the said oil and gas mining lesse and lessehold estates thereby created as above set out and described.

To have and to hold the same unto said the Elo Oil Company, its successors and assigns, subject however to all the rents, royalties, stipulations and covenants in said original lease contained.
