RIGHT OF WAY AGREEMENT

WITNESSETH: That said Grantor for and in consideration of the sum of ONE DOLLAR (\$1.00) to him in hand paid by said grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter contains d, does here by grant to the said Grantee, the Right of Way to lay, maintain, operate, relay and remove a pipe line and erect, maintain, operate and remove a regulator and stucco regulator building, for the pump ose of the transportation and regulation of Natural Gas, with right of ingress and egrees to and from the same, on, over and through certain lands situated in the County of Tulsa, State of Oklahoma, described as follows, to-wit:

All that part of Block Twenty (20) in Terwilleger Heights Addition to Tulsa North of a line drawn East and West One (1) foot South of the center of the Fourteen (14) foot radius at the North end of the said Block Twenty (20).

IT IS HEREBY MUTUALLY AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. That the said Grantor is to full use and enjoy the said premises, except the easement for the purpose hereinbefore granted to said Grantee.
- 2. That the Grantee shall have the right at any time to change the size of its line of pipe or regulator.
