## DECLARATION OF TRUST

OF  
MAE-LEE OIL & GAS COMPANY

OF

TULSA, OKLAHOMA.

WITNESS, this agreement by and between James R. Lee, R. M. Dick and B. B. See of Tulsa, Oklahoma, hereinafter called the Trustees of the first part and L. S. Henderson, W. L. Probst, of Tulsa, Oklahoma and G. R. Pittman of Miami, Oklahoma, hereinafter called subscribers of the other part, as follows, viz:--

The said named Trustees and subscribers, for themselves and for such other person or persons, who may hereafter become subscribers, have associated themselves together for the purpose of engaging in the Oil Business, generally including, production, refining and distribution and for such purposes have and do BY THESE PRESENTS, mutually COVENANT AND AGREE as follows, that is to say, the said named Trustees for themselves as Trustees, covenants, declares and mutually agrees with the said named subscribers, which agreement shall extend to and be binding upon all other persons, who may hereafter become subscribers, as follows, to wit:

I. It is provided and agreed that the title to all property, both real and personal, of ever kind and character, whatsoever, that may now or hereafter belong to the Trust Estate hereby created, shall be taken and held by the Trustees and their successors or successors in the name of

of Tulsa, Oklahoma, for the purposes, uses, trust and upon terms and conditions as hereinafter and hereinabove stipulated; it being further provided that, so far as possible, this Trust Estate shall be known and called the
