- 1. To encourage morality, impart instruction relative to, and promote the growth of the precepts, tenets and principles of the Ancient Arabiac Order of Nobles of the Mystic Shrine of North America among the Nobles of Akdar Temple, A.S.O.N. M. S. of Tulsa, Oklahoma; to aid and assist in the progress, growth, stability and permanency of said Akdar Temple, and as well to engage and assist in fraternal, social, educational, charitable, philanthropic, and benevolent projects for the benefit of the community generally in the City of Tulsa and elsewhere.
- 2. In furtherence of the purposes and aims above expressed; to acquire by purchase, lease, bequest or otherwise, and to own, hold and use for such purpose real estate and personal property, situate in the City of Tulsa, Tulsa County, Oklahoma, to erect, construct and build thereon a building or buildings for the use or benefits of said Akdar Temple and its Nobles and to furnish, equip, maintain, rent, lease, sub-lease, mortgage, transfer or otherwise dispose of its property and particularly to own and hold for the purpose aforesaid, the following described real estate, situate, lying and being within the City of Tulsa, Tulsa County, Oklahoma, to-wit:
