M O R T G A G E

On Royalty Interest in Oil and Gas Lease

To

SECURITY NATIONAL BANK

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, L. W. Aldrich, a single man, of the City of New York, in the State of New York, party of the first part, is the owner of an undivided one-eighteenth (1/18) interest in and to the royalty interest, said royalty interest being a one-eighth part of all the oil and gas produced from the following described property, to wit:

Southeast One Quarter (SE $\frac{1}{4}$ ) of Section Six (6) Township

Nineteen (19) North Range Twelve (12) East of the I. B. M.,

with all improvements thereon and appurtenances thereto belonging.

AND WHEREAS the said party of the first part desires to mortgage his said interest as above described to the Security National Bank of Tulsa, Oklahoma, party of the second part.

NOW THEREFORE, first party has mortgaged and does hereby mortgage to the second party the following:

All of the interest which said first party has in and to the oil and gas rights in the royalty interest, the same being an undivided one-eighteenth (1/18) of the one-third (1/3) royalty in all the oil, gas and other minerals located in or on or under the following described real estate located in Tulsa County, State of Oklahoma:

This mortgage is given to secure the principal sum of Twenty-Five Thousand (\$25,000.00) Dollars, with interest at the rate of ten per cent thereon per annum from maturity, according to the terms of one certain promissory note, described as follows, to wit:

In the principal amount of Twenty-five Thousand (\$25,000.00) Dollars, dated April 30, 1924, due ninety (90) days after date, and providing for interest at the rate of ten per cent (10% per annum after maturity, said note being signed by M.
