

official duties, shall be binding upon this Trust, and the Trustees to the extent, in the manner and form, and for the term and purpose expressed in such writing.

ARTICLE III.  
CAPITAL AND HOW DESIGNATED.

1. The capital of the said company shall be Two Hundred and Fifty Thousand Dollars (\$250,000.00), and for the purpose of defining the beneficial interests of the subscribers and their respective assigns, in the said estate, the said capital shall be divided into Twenty-five Thousand (25,000) shares of beneficial interest, of the par value of Ten Dollars (\$10.00 per share and classed as follows to-wit:

- 5000 shares to be known as Preferred Class "A"
- 7500 shares to be known as Preferred Class "C"
- 12500 shares to be known as Common Class "B"

ARTICLE IV.  
OFFICERS.

1. The principal place of business, offices and headquarters of this Trust shall be in the City of Tulsa, Oklahoma, and such other offices may be established and maintained by the Trustees at such place or places, and under such other name or names as they may deem advisable.

ARTICLE V.  
PURPOSE OF TRUST.

1. The primary purposes of this trust are:  
To open, establish, maintain, conduct and carry on a general Dry Cleaning, Pressing, Dyeing, Tailoring and Laundry Business.

ARTICLE VI.  
POWER OF TRUSTEES.

1. The said Trustees are hereby duly authorized and fully empowered to conduct and carry on the business of a General Laundry, and to wash, clean, scour, bleach, wring, dry, iron, color, dye, disinfect and deliver to customers, all kinds of wearing apparel, textile goods, materials and fabrics, by the use of machinery and by hand.

2. To conduct and carry on the business known as Dry Cleaning, and to solicit, receive and wash, steam, scour, clean, and otherwise treat, clean, press, iron, and repair, suits, coats, trousers, overcoats, top coats, dresses, skirts, furs, and other wearing apparel of all kinds.

3. To wash, steam, scour, clean, block and repair hats and caps.

4. To do, conduct, and carry on a General Tailoring Business, both as principal and agents;

5. To do, conduct, and carry on the business of cleaning carpets and rugs, by any and all the known processes and recognized methods of carpet cleaning;

6. To steam, wash, scour, clean, renovate and polish Sedans and other closed cars, both inside and out;

7. To steam, wash, scour, clean, and furnish silver and other metalware;

8. To acquire by purchase, lease, gift or otherwise real estate necessary and proper for the use of said business or any part thereof, and to furnish and equip the same with proper and necessary machinery, fixtures, vats, boilers, engines, steamers, tubs, wringers, ironers, presses and all other equipment necessary to properly conduct and carry on the said business or any part thereof.

9. Any branch or part of the said business or business may be established, conducted and carried on under a different firm name at the election and option of the Trustees.

10. To invest from time to time any moneys under the control of the Trustees, in any securities or property which the Trustees may select, in the same manner and to the same ex-
