PARTIAL RELEASE OF TRUST DEED.

KNOW ALL MEN BY THESE PRESENTS, That whereas, by instrument dated December b, 1923, and filed for record on December 7, 1923, and recorded in Hook 468, at page 557, of the title records of Tulsa County, Oklahoma, A. MILLER HAMMETT AND ADELAIDE E. HAMMETT, his wife, did convey to A. L. FARMER that certain tract or parcel of land situated in Tules County Etate of Oklahoma, described as follows, to-wit:
