ASSIGNMENT OF INTEREST OF CONTRACT OF OIL & GAS LEASE

Connelly hereby sells, transfers, assigns, and sets over, unto the said Tom M. Griffith One-eighth interest in a contract for an oil & Gas lease upon the following described property-towit:

SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 9, and the South half of the SW $\frac{1}{4}$ of Section 10, all in Township 18 North, Range 13 East, containing 120 Acres more or less.

It is hereby stipulated and agreed that the party of the first part has this day employed the services of Tom N Griffith as an Attorney and counselor at law, to prosecute, and defend any and all cases now of record or that may herein--after become of record and said services of the said second party, shall be in full consideration of the One-eighth interest herein before mentioned.
