The provision of Section 4 of said act emabling this estate is hareby accepted and applied, to-wit:

" Liability to third persons for act, omission, or obligation of a trustee or trustees of this trust, when acting in such capacity, shall extend to the whole of the trust estate held by such trustee or trustees, or so much thereof as may be necessary to discharge such liability but no personal liability shall attach to the trustee or the beneficiaries of such trust for any such sot, omission or liability.

Said trustee shall issue such certificates of interest herein as shall be just and suitable as well for the interests of the beneficiaries as for the progress of the estate and its business, to show the true and correct relative interest of the beneficiaries and said certificates when recorded on the books of said estate shall be evidence that the holder is a beneficiary hereof to the extent shown in such certificate.

After laying by a prudent reserve for bills and notes payable, depreciation, depletion, obsolescence, replacement, maintenance and routine working capital, the trustee shall annually distribute all net profits earned by the association during the year.
