taken up and disposed of at that time.

If this is acceptable to you, please confirm the same in writing, it being understood that your acceptance of these terms obligate you to carry them out for the common benefit of all persons interested. And if at any time it is desired by a majority of the holders of interest of said well in amount, to substitute some other trustee to perform the same function by this paper vested in you, it must be understood by your acceptance that you agree upon the rights of the said majority of the holders in amount to make such change. What is meant by this is to create a trust in you with the right in the majoirty to change to another trustee for the purpose of equiping, maintaining and operating this particular well.

A copy of the letter of May 6th from the Wilcox Oil & Gas Company and of my letter to you of May 24th is each attached to this and made a part of it just as if we had set it out in full so that all parties involved may be fully informed of the situation.
