

It is Therefore Ordered, Adjudged and Decreed by the Court, that the marriage relation heretofore existing between the Plaintiff, Ray B. Whitaker, and the defendant, Sophia M. Whitaker, be, and the same hereby is dissolved, and both parties are released from the same.

It is further Ordered, Adjudged and Decreed that the care, custody and education of Ray B. Whitaker, Jr., the child of the parties hereto, be confided to the plaintiff exclusively, and the defendant is hereby enjoined from interfering with said child or with plaintiff in his custody of said child, except that defendant be permitted to see and visit said child at all reasonable and proper times.

It is further Ordered, Adjudged and Decreed that the property settlement and division of property heretofore consummated between Plaintiff and defendant is in all respects just, fair and equitable, and that the same be, and it is hereby in all respects ratified, confirmed and approved; that in pursuance of said property settlement and agreement the plaintiff, Ray B. Whitaker, have and possess in his own right, and forever free, clear and discharged of and from any claim of the defendant, her heirs or assigns, the following described real estate, situate in Tulsa County, State of Oklahoma, to-wit:

The North Twenty-five (25) feet of Lot Ten (10) and the
South Twelve and One-Half (12½) Feet of Lot Eleven (11)
in Block Three (3) in College Addition to the City of Tulsa,
according to the recorded plat thereof,

together with all furniture and household goods heretofore owned and possessed by the parties hereto, together with all and any other property acquired by plaintiff subsequent to the filing of this cause.

It is further Ordered by the Court that this decree do not become absolute and take effect until six months from the date hereof.
