CONTRACT

GUARANTY

THIS CONTRACT, Made and entered into this the 6th day of June, 1924, by and between L. M. Graham and J. Frank Graham of Tulsa, Oklahoma, parties of the first part, and The Marion Oil Company, a common law trust, party of the second part; WITNESSETH:
