

said sum provided for in the last preceding paragraph, then and in such event, the said Exchange Trust Company, Trustee as aforesaid, upon demand in writing by the said Parties of the First Part or a majority thereof, will execute its Trustee's Deed covering said lands unto any person, persons, firm or corporation designated by a majority of the Parties of the First Part, and that upon the execution of said Trustee's Deed as aforesaid the Trustee herein is to be relieved of any liability or responsibility as such Trustee.

The parties of the First Part agree to advance to the Trustee from time to time sufficient sums of money to pay all the taxes against the several tracts of land deeded to the Trustee herein, and it is especially contracted and agreed that The Trustee shall not be responsible for the payment of said taxes.

EXTENSION OF TIME FOR THE CITY OF TULSA
OF THE PARK BOARD OF SAID CITY OF TULSA
TO PURCHASE CERTAIN PROPERTY.

WHEREAS, on July 1st, 1922, Frank H. Reed, Alva J. Niles, W. G. Skelly, J. J. McGraw, D. B. Mason, Eugene Lorton, C. J. Wrightsman, J. A. Hull, Fred W. Insull, J. H. Gardner, H. O. McClure, C. A. Mayo, and A. E. Bradshaw, being desirous of procuring certain lands for park purposes for the City of Tulsa, Oklahoma, entered into a certain Trust Agreement with the Exchange Trust Company, a Corporation, of Tulsa, Oklahoma, as Trustee, in which said Trust Agreement it was provided that said parties would cause to be conveyed to said Trustee, certain lands which were to be sold to the city of Tulsa, Oklahoma, for park purposes, a copy of said Trust Agreement is hereto attached, marked Exhibit A, and made a part hereof; and

WHEREAS, under the terms of said Trust Agreement there has been conveyed to said Exchange Trust Company as Trustee, the following described lands:

Southwest Quarter of Northwest Quarter, and Northeast Quarter of Southwest Quarter of Section 14, Township 20 North, Range 13 East of the I.B. & M., in Tulsa County, Oklahoma, containing 80 acres, more or less,

The West Half of Northwest Quarter of Southeast Quarter of Section 11, Township 20 North, Range 13 East, in Tulsa County, Oklahoma, containing 20 acres, more or less,

The South Half of Southeast Quarter of Section 10, the North Half of Southwest Quarter of Section 11; that part of the Southeast Quarter of Northwest Quarter of Section 11 lying South and East of the center line of Bird Creek Channel, the same being 15 acres more or less; and that part of the Southwest Quarter of Northwest Quarter of Section 11 lying South of the center line of Bird Creek channel, the same being a triangular piece of land in the said Southwest corner of the said Southwest Quarter of Northwest Quarter of said Section 11, containing approximately ten acres; all of said land being in Township 20 North, Range 13 East, in Tulsa County, Oklahoma, containing 185 acres, more or less,
