

of eighteen months from the 1st day of July, 1923, and agree that if within the eighteen months from the 1st day of July, 1923, the City of Tulsa, or its Park Board, shall tender and pay unto said Trustee a sum equal to the aggregate amounts the parties of the first part have paid as the purchase price of said land, together with interest thereon at the rate of ----- per cent per annum on the several sums and amounts so paid by said parties of the first part in said Trust Agreement for the several parcels of land hereinbefore referred to, and in case said payment is so made, that the Trustee is hereby authorized, empowered and directed to execute its Trustee's Deed to said City of Tulsa, or to its Park Board, covering said lands above described.

#### SUPPLEMENTAL AGREEMENT.

This supplemental agreement made and entered into this 8th day of October, 1923, by and between Frank H. Reed , Alva J. Niles, W. G. Skelly, J. J. McGraw, D. B. Mason, Eugene Lorton, C. J. Wrightsman, J. A. Hull, Fred W. Insull, J. H. Gardner, H. O. McClure, C. A. Mayo, and A. E. Bradshaw, parties of the first part and Exchange Trust Company, a corporation of Tulsa, Oklahoma, Trustee, as party of the second part, WITNESSETH: That

WHEREAS on the 1st day of July, 1922, the parties of the first part herein being desirous of providing and purchasing certain lands for park purposes for the City of Tulsa, Oklahoma, entered into a certain Trust Agreement with the Exchange Trust Company, a corporation as party of the second part, in which said Trust Agreement it was provided that said parties of the first part would cause to be conveyed to said party of the second part, certain lands which were to be sold to the City of Tulsa, Oklahoma, for park purposes , a copy of said Trust Agreement is hereto attached, marked Exhibit A, and made a part hereof; and

WHEREAS, under the terms of said Trust Agreement there has been conveyed to said Exchange Trust Company , as Trustee, the following described lands;

Southwest Quarter of Northwest Quarter; and Northeast Quarter of Southwest Quarter of Section 14, Township 20 North, Range 13 East of the I.B. & M., in Tulsa County, Oklahoma, containing 80 acres, more or less,

The West Half of the Northwest Quarter of Southeast Quarter of Section 11, Township 20 North, Range 13 East in Tulsa County, Oklahoma, containing 20 acres, more or less,

The South Half of the Southeast Quarter of Section 10, the North Half of Southwest Quarter of Section 11; that part of the Southeast Quarter of Northwest Quarter of Section 11 lying South and East of the center line of Bird Creek Channel, the same being 15 acres more or less; and that part of the Southwest quarter of Northwest Quarter of Section 11
