ASSIGNMENT OF OIL AND GAS MINING LEASES

KNOW ALL MEN BY THESE PRESENTS: That, WHEREAS, EMILE OFFENBACHER, of Tulsa, Oklahoma is the owner of certain Oil and Gas Mining Leases and Leasehold Estates, thereby created, covering the lands situated in Tulsa County, Oklahoma, said leases and leaseholds being particularly described as follows:
