THAT WHEREAS, on the 7th day of April, 1923 in the District Court in and for the County of Tulsa, State of Oklahoma, at the March term of said Court, in a certain action therein pending wherein D. E. Kneedler, was plaintiff, L. R. Epps, Lilliam Epps, A. S. Huggins, bracie O. Pappan, and William L. Pappan, were defendants, and Ella Knæedler was defendant and cross petition, the said Plaintiff, D. E. Kneedler, by the consideration of the Court recovered a judgment against the defendants, Gracie O. Pappan and William L. Pappan, and each of them, for the foreclosure of a mortgage upon the following described land situated in Tulsa County, Oklahoma.
