The party of the first part hereby makes the following special covenants to and with the said party of the second part and their assigns, to-wit:

FIRST. That said first party will procure separate separate policies of insurance against fire and tornadoes, each in the sum of ----Dollars, and maintain the same during the life of this mortgage for the benefit of the mortgagee or their assigns, and made payable to the mortgagee or assigns as his or their interest may appear.

SECOND. That the first party will pay all taxes and assessments, whether general or special, lawfully levied or assessed on said premises, before the same become delinquent.

THIRD. That the said party will keep and maintain all improvements on the premises 480 in good conditions; commit or suffer no waste thereon, and not allow said premises to become in a dilepidated condition.
