MEMORANDUM OF AGREEMENT

Whereas Thos. J. Green, E.S. Johnson, W.H. Johnson and R.W. Myers have agreed to promote the drilling of a well for oil and gas in the

SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 10, Twp. 19 N. Range 13 East, being part of the Crowell Estate, it being the intention of the parties above named to sell an undivided interest in the lease to drill the said well;

It is mutually agreed that any interest not sold to finance the drilling of the said well is to be equally divided between, Thos. Green, Johnsons and Myers, a one third each of any undivided interest that may be left.

This agreement also extends to any other acreage acquired for the drilling of the said well in Section 10, Twp. 19, R. 13 by any of the parties above mentioned.

The said lease being in the name of Thos. Green this agreement is executed and delivered so each party named herein may understand the interest that shall be assigned to him when the said well is completed.
