NINETEENTH. It is covenanted and agreed between the parties hereto that the word "CORPORATION" when used in these presents, means the party issuing the Bonds herein referred to; that the word "TRUSTEE" means the Corporation charged with the execution of the Trust herein, whether the same be the TITLE GUARANTEE AND TRUST COMPANY, of Tulsa, Oklahoma, or any successor or successors in the Trust hereby created; that the word "TRUSTEES" means the Michigan Trust Company and Noyes L. Avery, or their successor or successors in this and under a First Mortgage and Deed of Trust heretofore created; that the word "BOND", "BONDHOLDER" and "HOLDER" shall include the plural as well as the singular number, and the term "MAJORITY" shall signify the majority in amount.

COMPARED

It is covenanted and agreed that this Indenture made and executed in several counterparts, each of which so executed shall be deemed to be the original, and such counterparts shall together constitute but one and the same instrument.
