

of the above lands for oil and gas, and if possible, on or before the 15th day of each month, shall render to parties of the first and second parts, duplicate, itemized statements of expenses incurred in the development, equipment and operation of said lease, after the completion of the well above mentioned, and the parties of the first and second parts shall pay their proportionate share of such expenses, within ten (10) days after receipt of such statements. The party of the third part shall be entitled to charge against said one hundred and twenty acre lease, the sum of One Hundred (\$100.00) Dollars per month to cover the cost of book-keeping, superintendants, automobile, and all other over-head expenses, except the cost of actual superintendence of the lease and other labor expenses actually performed on the leased premises, and materials and supplies furnished thereon.

SIXTH; The parties of the first and second parts hereby grant to the party of the third part, a lien on their entire interest in said leasehold estate, to secure the payment by them to third party of all bills for expenses herein provided for, that may have been theretofore paid by party of the third part.
