Harn and his wife, Nora Harn, all of Tulsa County, and State of Oklahoma, owners of the following described real estate in Tulsa County, State of Oklahoma, described as follows, to-wit;

The East Half(E 1/2) of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of Section Twenty Seven (27) Township Nineteen (19) Range Twelve (12) East, hereby certify that they have caused the same to be surveyed into blocks, lots, streets and avenues, in conformity to the annexed plat which they hereby adopt as the plat of the above described land under the name of Greenfield Acres, and do hereby dedicate, subject to the conditions and restrictions hereinafter named, all of the streets and avenues shown upon said plat to public use.
