ASSIGNMENT OF OIL AND GAS LEASE.

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, said lease was duly approved by the Secretary of the Interior of the United States on the 14th day of September, 1908; and

WHEREAS, said lease is duly recorded in Book 53, page 4, in the office of the County Clerk of Tulsa County, State of Oklahoma; and

WHEREAS, said lease and all rights thereunder, or incident thereto, are now owned by the Mary Oil and Gas Company, an Oklahoma Corporation, as to the following described real estate and premises, situate in Tulsa County, State of Oklahoma, to-wit:

The West Half of the Southeast Quarter
(W $\frac{1}{2}$ of SE $\frac{1}{4}$) of Section Six (6), Township
19 North, Range 12 East, of the Indian
Meridian, and the Northeast Quarter of the
Southeast Quarter (NE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section
6, Township 19 North, Range 12 East, of
the Indian Meridian

except as to the oil and gas which may be prospected for and found below the top of the level of what is known as the Mississippi Line, as to the forty acres last above described.

NOW, THEREFORE, for and in consideration of One Dollar and other good and valuable considerations, receipt whereof is hereby acknowledged, the said Mary Oil and Gas Company does hereby bargain, sell, transfer, assign and convey unto the Sand Springs Home, an Oklahoma Corporation of Sand Springs, Oklahoma, all its right, title and interest in and to said lease and rights thereunder insofar as it covers the following described real estate and premises situate in Tulsa County, State of Oklahoma, to-wit:

The West Half of the Southeast Quarter
(W $\frac{1}{2}$ of SE $\frac{1}{4}$) of Section 6, Township 19
North, Range 12 East, and the North -
east Quarter (NE $\frac{1}{4}$) of Southeast Quarter
(SE $\frac{1}{4}$) of Section 6, Township 19, North
Range 12 East,

except as to the oil and gas which may be prospected for and produced, as to the forty (40) acres last above described, from below the top of the level of what is commonly known as the Mississippi line.

This assignment is executed and delivered for the purpose of completing and validating the title of the Sand Springs Home, a Corporation.
