payable at St. Charles , Missouri, with six per cent interest per annum. payable semi- annually and signed by John W. Happel and Roberta P. Happel.

Said first parties hereby covenant that they are owners in fee simple of said premises and that they are free and plear of all incumbrances whatsoever.

That they have good right and authority to convey and encumber the same, and thay will warrant and defend the same against the lawful claims of all persons whomsoever, Said first parties agree to insure the buildings on said premises in the sum of \$2000.00 for the benefit of the mortgagee and maintain such insurance during the existence of this mortgage. Said first parties agree to pay all taxes and assessments lawfully assessed on said premises before delinquent.

Said first parties waive notice of election to declare the whole debt due as ahowa and also the benefit; of stay, valuation. or appraisement laws.
