SEWER CONTRACT;

COMMISSION

THIS AGREEMENT, made and entered into this 3rd day of July, 1924. by and between the City of Tulsa, Oklahoma, party of the first part, and of Tulsa County, Oklahoma State, part of the second part. WITNESSETH;

For inconsideration of the use of and connection with the sewer system in SEWER DISTRICT NO- 175 of said City of Tulsa, and the covenants and agreements herein contained, the said part of the second part do hereby covenant and agree with the said City of Tulsa, Oklahoma as follows, to-wit;

That the said part of the second part the fee owner of the following property covered by this contract, to-wit;

Lot 14, Block 4, Crutchfield Addition to the City of Tulsa,
 Oklahoma, according to the duly recorded plat thereof.

That the said part of the second part hereby authorized and permitted to construct, connect with and make use of the sewer in SEWER DISTRICT NO*175 of the City of Tulsa, upon the said part of the second part paying the entire cost of such sewer construction, connection and use, and in addition paying to the said City of Tulsa, the sum of Five (5%) per centum of the cost of such construction, and use, as an engineering fee for the supervision of such
