MODIFICATION OF OIL LEASE.

WHEREAS, heretofore, on the 15th day of February, 1924 G. A. Wright and Ella M. Wright, his wife, did execute, acknowledge and deliver their certain oil and gas mining lease to Houston M. Morgan, covering the following described lands. to-wit;

All that certain Tract of land situated in the County of Tulsa, State of Oklahoma, as follows. to-wit;

A Tract of land in the Northwest corner of Fractional Section (8) Eight, of Fractional Township (19) Nineteen, of Range (12) Twelve, bounded and described as follows.
