ASSIGNMENT OF OIL AND GAS LEASE;

WHEREAS, on the 15th day of February, 1924 a certain oil and gas mining lease was made and entered into by and between G. A. Wright and Ella M. Wright, Lessors, and Houston M. Morgan. Lessee. covering the following described land in the county of Tulsa and state of Oklahoma, to-wit;

A Tract of land in the Northwest corner of fractional section Eight (8) of fractional Township Nineteen (19), of Range Twelve (12), bounded and described as follows; Beginning at a point 355.5 feet south, and 16.5 feet East of the Northwest corner of the fractional Section Eight (8) of the fractional Township Nineteen (19) North, of Range Twelve (12) East; runs thence North parallel to the West line of said Section Eight (8) a distance of 117 feet; thence North ^{nine} ~~sixty-two~~ degrees five minutes East ($69^{\circ} 5' E.$) a distance of 400 feet; thence on a five degree and forty minute curve to the right, a distance of 136.8 feet; thence south parallel to the West line of the said Section Eight (8), a distance of 271 feet; thence South nineteen degrees and twenty-eight minutes West ($19^{\circ} 28' W.$) a distance of 31.8 feet; thence West parallel to the North line a distance of 488.9 feet to the point of beginning and all that part of fractional Section Eight (8) lying North of the M. K. & T. right-of-way, containing two and six tenths (2.6) acres more or less; and

A tract of land in the Northwest corner of the fractional Section Eight (8) of Fractional Township Nineteen (19), of Range Twelve (12), bounded and described as follows; Beginning at a point 355.5 feet South and 545.4 feet East of the Northwest corner of the fractional Section Eight (8), runs thence North a distance of 308.2 feet; thence North eighty-two degrees and sixteen minutes East ($82^{\circ} 16' E.$) and on five degree and forty minute curve to the right; a distance of 90.6 feet; thence South a distance of 323.2 feet; thence West a distance of 90 feet to the point of beginning; containing 0.652 of an acre more or less; and

A tract of land in the Northwest corner of the fractional Section Eight (8) of the Fractional Township Nineteen (19), of Range Twelve (12), v. bounded and described as follows;
