THIS; AGREEMENT. Made and entered into on this 26th day of November, 1924 by and between HOUSTON M. MORGAN, RUBY MAY HANCOCK, INDIAN RECORD ASSOCIATION, by its officers and Trustees. NUECES OIL COMPANY, a corporation. G. N. Wright and Mattie Archer, parties of the first part, and the MUTUAL OIL COMPANY, a Maine Corporation, party of the second part;

WITNESSETH; That in consideration of the payment by the party of the second part to the parties of the first part of the sum of One (\$1.00) Dollar and other good and valuable considerations, the parties of the first part do hereby grant. bargain. sell. assign. transfer and convey unto the party of the second part. their entire right. title and interest in and to the oil and gas mining lease dated February 15th, 1924, given by G. A. Wright and Ella M. Wright to Houston M. Morgan. covering the following described land, to-wit;

All that certain tract of land situated in the County of Tulsa, State of Oklahoma as follows - to-wit;
