No. 258913 - NRS COMPARED RIGHT OF WAY AGREEMENT.

- In consideration of One Hundeed & Sixty & no/100 Dollars this day paid to M A YOUNKMAN By Cosden Fipe Line Company, receipt whereof is hereby acknowledged do hereby grant and convey unto said Cosden Fipe Line Company, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil, over, through and upon that certain tract of land situated in Tulsa County and thus described:

> E2 NE4 32-19-12. 10 Inch Oil Line running throuland next to Suction line and buried below plow depth line to run 3 foot inside property line.

Also, there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of such land as may be necessary for said pipe line and for said telegraph and telephone line and shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of the grants herein granted, including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining, repairing and restoring of said pipe line and said telegraph and telephone line, and for removing of same when desired by the grantee, its successors and assigns. And the right to lay, construct, operate maintain and remove additional pipe lines, telegraph and telephone systems, over said lands, parallel with the above lines, is hereby granted to Cosden Pipe Line Company, its successors and assigns, upon payment of an additional sum equal to the consider ation above named.

The damage for and because of the laying of the first line of pipe are included in the above payment. All damages thereafter to fences, crops and premises, which may be suffered by reason of maintenance, operation or alteration of said lines of pipe, said damages. if not mutually agreed upon to be ascertained and detormined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by Cosden Pipe Line Company, its successors or assigns, and the third by the two so appointed as aforesaid, and the award of two of such three persons Bhall be final and conclusive.

TO HAVE AND TO HOLD the said easement unto the said Cosden Pipe Line Company its successors and assigns, so long as the same shall be useful for the purpose desired by said grantee, which by the acceptance hereof covenants and agrees with the Grantor that the pipe line shall be buried so as not to interfere with the cultivation of the same.
