DRILLING CONTRACT;

This agreement, made and entered into, by and Between the Bruner Oil Company, (A Common Law Trust) of Sand Springs, Okia, Party of the first part, and the Grahoma Oil Company, an Oklahoma corportion, Party of the second part,

WITNESSETH; Party of the first part and the legal owners of a contract for assignment of the oil rights to the South East Quarter of the South West of Sec, Five (5), Twp Nineteen, (19) Range Twelve, Tulsa County, Oklahoma, being a part of the Mary Partgidge allotment, from the Mary Oil and Gas Company,

Party of the second part is to drill a well in the North West corner of the above allotment to the Wilcox Sand or to the Turkey Mountain Sand in event that no paying well is encountered in the Wilcox Sand for a consideration of \$4,000.00 cash, payament to be made as hereinafter provided,

In the event that a paying oxl well is encountered in any sand, party of the second part is to equip same into the tanks and is to charge party of the first part at actual cost, 75% of such cost of equipping well into tanks, party of the second part to assume 25% of such cost as their prorata as hereinafter provided,

In the event that a dry hole or non-productive well is drilled party of the second part shall be entitled to recover and salvage allmaterial placed thereon by them,

Drilling is to commence on or before September First, 1924, and is to be performed with due diligence and in workmanlike manner in accordance with our contract with Mary Oil & Gas Company,
