OIL AND GAS LEASE

AGREEMENT, Made and entered into the 9th day of May, 1924, by and between Creekmore Wallace, of Sapulpa, Oklahoma, party of the first part, hereinafter called lessor (whether one or more) of Sand Springs Home a Corporation, party of the second part, lessee.

WITNESSETH, That the said lessor, for and in consideration of One (\$1.00) Dollars cash in hand, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee, for the sole purpose of mining and operating for oil and gas, and laying pipe lines, and building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa, State of Okla. described as follows, to-wit;

An undivided one-half interest in and to the South-east Quarter (SE $\frac{1}{4}$) of the North-west Quarter (NW $\frac{1}{4}$) (It being understood that the party of the first leases his entire interest) of Section 25 Township 19 Range 11 and containing 40 acres, more or less.
