This Contract and Agreement made and entered into on this the 1st. day of April, 1924, by and between C.F. Bliss of Tahlequah, Oklahoma party of the first part, and G.W. Hickernell of Warren Pennsylvania, as the lessee, and Ella Gravitt, of Tulsa, Oklahoma, the present owners of the land.

WITNESSETH: That, Whereas, on March 12th. 1917, Mirah A. Higginbotham, nee Faucette made and entered into a certain written Agreement, Power of Attorney, Contract and Conveyance with the party of the first part hereto, which said instrument was duly recorded in the records of Tulsa County Oklahoma in Book 209, at Page 391, covering the following described lands, to-wit:
